#### 7.a. Morehead Rowan County Chamber of Commerce

Mr. Jason Slone was present and gave the report for the Morehead Rowan County Chamber of Commerce. Mr. Slone discussed membership and recruitment. He also reported that the Annual Banquet will be held November 16, 2021, and that they are working on a business after hours event. Mr. Slone also discussed that the chamber was considering making the monthly meeting a breakfast instead of a luncheon.

#### 7.b. Economic Development Council

Ms. Rosas also reported that the Morehead Utility Plant Board received a Technical Assistants Grant (TAG) of \$51,000 and with that they are planning on giving the Morehead Fire Department an RMLD, which is a Remote Methane Leak Detection piece of equipment and also a multi-gas personal monitor meter to help them with safety. Ms. Rosas also stated that the Morehead Utility Plant Board would be getting the same equipment.

Rodney Fouch was present to report on Future Growth and Development/Projects for the city. Mr. Fouch reported that final approval had been given for T-Mobile and Tumbleweed. Mr. Fouch also reported that there was an eightplex going up off Heights Avenue. Mr. Mike Kash asked for a

report on the property up by Kroger and Mr. Fouch then reported that there were two more restaurants coming, one has had final approval and one other needs planning commission approval.
