5. Public Comments

Mayor White-Brown introduced some guests from the Morehead Boys Scout troop. Mayor White-Brown also reported that the scouts are learning about government and local communities. Mr. Tom James introduced the Weeblos troop. Mr. Tom James spoke about the troop leaning Citizenship and then he thanked the mayor and council for allowing them to sit in on the meeting.

5.a. Tim Wright

Mr. Tim Wright and Mr. Rodney Mora were present to speak to council about their business Wildcat Disposal. They explained that they are looking to start their business for renting roll off dumpsters in the city. Mr. Wright explained that in their research they found that there was an ordinance that required them to get approval from council to operate in the city. Mr. Wright explained the business to council including the size of dumpsters they would have available. He also explained that he had contacted Advanced Disposal and that they didn't supply this type of service. Mr. Wright also reported to council that he had intentions of getting the proper applications and licensing with the state and DOT number. There was discussion had regarding the pricing per day and cost if you go over the initial fee for three days. Attorney Joyce Planck Stevens reported that the reason Mr. Wright and Mr. Mora was there is because our ordinance provides that no one can operate a business within the city with regard to garbage unless they have written authorization from council. Mr. Glen Teager asked Attorney Stevens about the reason this is in the ordinance with brief discussion regarding the type of business. Mr. Jim Tom Trent asked Mr. Greg Jones if we get calls for this type of service.

5.b. Edna Schack

Ms. Edna Schack was present to discuss West Morehead Streets and Drainage at the new development in this area. Ms. Schack showed a power point presentation regarding the Center Street and Heights Avenue area. Ms. Schack discussed that she loved the fact that the city is getting nice looking housing but that the city needs to keep infrastructure up with the development. Ms. Schack reported that there are people who walk and have wheelchairs, so the city needs to make sure that we have sidewalks. She also discussed the streets and increased traffic that will cause problems. Mr. Jim Tom Trent asked if lighting would help; Ms. Edna Schack was in agreement with this as long as it didn't shine in the windows.

6. Mayor's Report

Mayor Laura White-Brown reported regarding the Economic Development Council and advised that the search for a new director would continue through the end of the year.

Mayor Laura White-Brown reported that the park is starting to put up their holiday décor. Mayor White-Brown also reported that the city is in the final stages of having a draft of a new employee handbook from KLC and that she is hoping to have the draft to council very soon. Also, discussed that she put together a committee for the downtown TIF project and the stage rental discussion is coming up later in this agenda.

Mr. Teager asked if the mayor could send out the dates for the downtown TIF project committee meeting.

7. Quarterly Reports

8. Morehead-Rowan County Tourism, Morehead Conference Center & Rowan County Arts Center

Ms. Joy Brown was present to report for the Morehead-Rowan County Tourism, Morehead Conference Center and Rowan County Arts Center. Ms. Brown reported that the sign outside the conference center is gone. It was removed due to the technology being outdated and that it would be too expensive to replace. The souvenir shop in the Depot has been expanded and Ms. Paige Lewis is now running the souvenir shop. Ms. Brown also reported that the first stage of the art walk has been installed. Ms. Brown reported about the Big Turtle 50 miler was the biggest it had ever been. Ms. Brown reported that Ms. Edna Schack came to her with a project idea to do painted turtles like Lexington does the painted horses, but that the turtles would be cheaper. Also, Ms. Brown reported that they are still working on mapping trails in Morehead and that this is a big project. Ms. Brown also reported that they have a bunch of loop trails which bring a lot of people to Morehead. Also Ms. Brown reported they are working on touch screen Kiosk that would be available downtown and are interactive and that information could be given regarding real time updates. Mr. Matt Hamilton thanked Tourism for their support and donation to Holidays in the Park and a Grant for \$25,000 that we applied for help fund NBA basketball.

9. Morehead Utility Plant Board Report

Ms. Holly Rosas was present to report for the Morehead Utility Plant Board. Ms. Rosas reported that the water plant opened for bid and went to Judy Construction. Ms. Rosas also reported about water meter change outs and training that they had this month. Ms. Rosas reported that the Morehead State University water lab is closing, and that Morehead Utility Plant Board was opening their own water lab. Ms. Rosas also reported that a company called Servline contacted them, and they are a third-party insurance company that customers could contact and get insurance to help replace lines that might be their responsibility in the event something might happen such as a water leak.

10. Future Growth/Development/Projects for The City

Mr. Rodney Fouch gave report on Future Growth and Development/Projects for the city. Mr. Fouch reported that council has their new project list in addition to ongoing projects. He stated that they were down this month.

Mr. David Rhodes was present to update council on the Police/911 Facility. Mr. Rhodes reported that there will be a change order next month regarding some hardware/sprinkler system. The change order is less than \$24,000. Mr. Rhodes reported that there was one more slab to pour and that walls are going up on the second floor, and that framing on lower level should begin soon. Mr. Rhodes reported that the roof is the next critical thing and that the schedule would have to be revised due to some of the delays that they have encountered.
